Probably the most influencing antitrust law regime in the world, the US-American antitrust law, likewise offers guidelines for the assessment of technology pools - the Antitrust Guidelines for the Licensing of Intellectual Property. Both guidelines differ considerably as to content, scope, and detail. The book provides support in the antitrust analysis of a technology pool as well as examining whether the guidelines actually comply satisfactorily with their guiding function.
